### SUGGESTED SPECIFICATIONS

Model A132408S-VR-BF3 is a Vandal Resistant, Wall Mounted, Pressurized Bi-Level Chilled Drinking Fountain and Bottle Filler combination that shall deliver a minimum of 8.0 GPH (30.3 LPH) of water at 50°F (10°C) cooled from 80°F (26.7°C) inlet water and 90°F (32.2°C) ambient. Unit shall be made from 18 gauge, 304 Stainless Steel with a brushed finish. Unit shall be activated by Chrome Plated Brass Pushbutton using less than 5 pounds of force. Bottle Filler shall be activated by a Pushbutton using less than 5 pounds of force. Cooling system shall use R-134a refrigerant and be Capillary Tube regulated. An Adjustable Thermostat with an off position shall regulate the refrigeration system. Bubblers shall be polished Stainless Steel with non-squirt features and operate on a water pressure range of 20-105 PSIG. Unit shall have uniquely designed, Two-Piece Contoured Bowls with P-Traps integral to the unit. Chiller shall be listed by Underwriters Laboratories for both the US and Canada and is compliant to the Air Conditioning and Refrigeration Institute Standard 1010. Fountains and Chiller are certified to ANSI A117.1, NSF/ANSI 61, Section 9, Public Law 111-380 (NO-LEAD), and CHSC 116875. Fixture meets ADA, ADA Standing Person, and ADA Child requirements when mounted appropriately.




